OF THE SIXTY-FIFTH LEGISLATURE OF THE STATE OF IDAHO**

The table published herein lists all pending rulemakings that were reviewed during the 2020 legislative session and shows the individual rule sections that were affected by these rulemakings. The table includes the docket number of each affected chapter, the section numbers of the amended rule, the Bulletin publication volume numbers, and the final effective date of the rule.

Effective Dates:

Effective dates for the pending rules reviewed and approved by the 2020 Idaho Legislature are as follows:

Pending Rules (non-fee):

Effective date – March 20, 2020 (3-20-20), unless otherwise specified in the pending rule.

Pending Fee Rules:

Null and void and of no force and effect.

A concurrent resolution(s) approving pending fee rules was not adopted by the 2020 Idaho Legislature as is required by Section 67-5224(5)(c), Idaho Code, in order for the pending fee rule to become final and effective. Consequently, all pending fee rules reviewed by the 2020 Idaho Legislature are null and void and of no force and effect.

Pending Rulemakings That Expired:

The following table includes rulemakings that amended rule chapters that expired after the 2019 legislative session and were re-promulgated as omnibus fee rulemakings and submitted for final approval during the 2020 legislative session. As indicated in the table, in those instances where the omnibus pending fee rule chapters were not approved as final for lack of a concurrent resolution and expired, any subsequent rulemakings amending those chapters are rendered null and void and of no force and effect.

In the table the column showing the “Final Effective Date” lists those Omnibus Pending Fee Rules that did not become final and effective as “*Not Approved.*”

Those pending rulemakings amending the expired omnibus fee rules are listed as “*Expired.*”
