IDAPA 07.05.01 - Rules of the Public Works Contractors License Board - Proposed Rule (Docket No. 07-0501-1601)

(1) 07.03.01 - Rules of Building Safety - Proposed Rule (Docket No. 07-0301-1601)

The Division of Building Safety submits notice of proposed rulemaking at IDAPA 07.03.01 - Rules of Building Safety. The proposed rule updates an incorporation by reference of the International Building Code. The Division states that the 2015 commercial building and energy codes have been adopted while the standards of the residential building and energy codes are maintained at the existing 2012 level.

The Division states that negotiated rulemaking was conducted and that notice was published in the March edition of the Idaho Administrative Bulletin, Vol. 16-3, pages 13-14. There is no fiscal impact associated with this rulemaking.

The proposed rule appears to be within the statutory authority granted to the Division in Section 39-4107, Idaho Code.

(2) 07.05.01 - Rules of the Public Works Contractors License Board - Proposed Rule (Docket No. 07-0501-1601)

The Division of Building Safety submits notice of proposed rulemaking at IDAPA 07.05.01 - Rules of the Public Works Contractors License Board. For the Type 4 specialty construction category of "13800 Instrumentation and Controls", this proposed rule accounts for the installation of certain electrical wires, equipment and apparatus to convey electrical current.

The Division states that negotiated rulemaking was not conducted because the rule is simple in nature. There is no fiscal impact associated with this rulemaking.

The proposed rule appears to be within the statutory authority granted to the Division in Section 54-1907, Idaho Code.

INCORPORATION BY REFERENCE SYNOPSIS

In compliance with Section 67-5223(4), Idaho Code, the following is a synopsis of the differences between the materials previously incorporated by reference in this rule that are currently of full force and effect and newly revised or amended versions of these same materials that are being proposed for incorporation by reference under this rulemaking.

The following agency of the state of Idaho has prepared this synopsis as part of the proposed rulemaking for the chapter cited here under the docket number specified:

DIVISION OF BUILDING SAFETY
IDAPA 07.01.06 - Rules of Building Safety
Proposed Rulemaking - Docket No. 07-0301-1601

This rulemaking adopts the 2015 International Building Code (IBC), 2015 International Existing Building Code (IEBC), and the commercial provisions of the 2015 International Energy Conservation Code which serve as the basis for the Idaho Energy Conservation Code. Further amendments to the 2015 IBC include adding lodging houses with five or fewer guest rooms to the R-3 residential occupancy, retaining existing amendments requiring drinking fountains in occupancies with an occupant load of more than 30 persons, and service sinks in business and mercantile occupancies with an occupancy load of more than 30 persons except for restaurants. Finally, it adds an exception to the commercial energy code for certain air filtration and treatment systems in which it would not be feasible to require economizers to draw outside cool air. A copy of the Table of Contents and an index identifying significant changes to the 2015 IBC is attached to this summary. Additionally, the Table of Contents for the 2015 IEBC, and the commercial provisions of the 2015 IECC is also attached. More detailed information about any change to these codes may be available upon request to the Division of Building Safety.

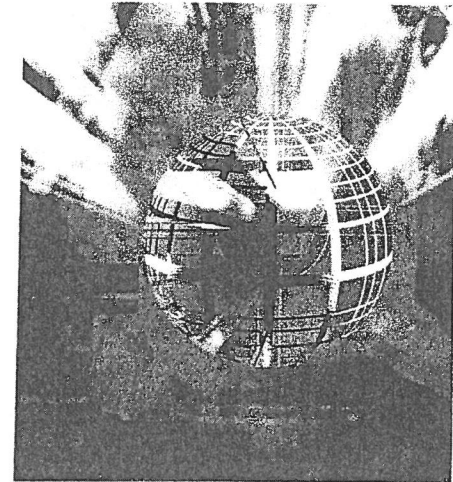
