11.10.02 - RULES ESTABLISHING FEES FOR SERVICES - IDAHO CRIMINAL JUSTICE INFORMATION SYSTEM

000. LEGAL AUTHORITY.

These rules are authorized by Section 67-3010, Idaho Code.

001. TITLE AND SCOPE.

- **01. Title**. These rules shall be cited as IDAPA 11.10.02, "Rules Establishing Fees for Services Idaho Criminal Justice Information System." (3-30-01)
- **O2. Scope**. The rules relate to the governance and operation of criminal history records and crime information. (3-30-01)

002. WRITTEN INTERPRETATIONS.

003. ADMINISTRATIVE APPEALS.

Administrative appeals under this chapter shall be governed by the rules of administrative procedure of the attorney general, IDAPA 04.11.01, "Idaho Rules of Administrative Procedure of the Attorney General." (3-30-01)

010. **DEFINITIONS.**

Except as otherwise specifically provided, the terms defined in Section 67-3001, Idaho Code, shall have the same meaning in these rules. (3-30-01)

011. FEES FOR SERVICES.

- **01. Fingerprint Check**. The Bureau shall charge a fee of not more than ten dollars (\$10) for each fingerprint check requested for other than law enforcement purposes. (7-1-96)
- **02. Name Check**. The Bureau shall charge a fee of not more than ten dollars (\$10) for each name check requested for other than law enforcement purposes. (3-30-01)

012. NON-EXPANSION OF SERVICES.

Nothing within these rules shall be construed to alter or expand the services which will be provided to those requesting fingerprint checks and name checks. (7-1-96)
