#### 02.04.06 - REQUIREMENTS FOR LICENSED DAIRY PLANTS

000. LEGAL AUTHORITY.

This chapter is adopted under the legal authority of Title 37, Chapter 4, Idaho Code.

#### 001. TITLE AND SCOPE.

**01. Title**. The title of this chapter is rules of the Department of Agriculture governing IDAPA 02.04.06, "Requirements for Licensed Dairy Plants." (4-6-05)

**02. Scope**. This chapter has the following scope: These rules shall govern the requirements for the design, construction, and operation of dairy plants licensed to process milk for manufacturing purposes.
