NOTICE OF INTENT TO PROMULGATE RULES - NEGOTIATED RULEMAKING

This rulemaking will likely delete Subsections 18.01.04.016.02 and 18.01.04.016.03 from Rule 18.01.04 to conform the rule to the interpretation of Idaho Code 41-1042 consistent with the Idaho Supreme Court's ruling in *Two Jinn v. Idaho Department of Insurance*, 154 Idaho 1, 293 P.3d 150 (2013).
