This chapter of rule has not been updated for several years and the Department is soliciting input on the EMS Grant rules to update and bring them current with new technology. These rules will have obsolete language removed, may amend or adjust grant criteria, and will also be moved to the Department's Emergency Medical Services rules under IDAPA 16.01.04.
