02.06.29 - RULES CREATING THE ELBA SEED POTATO CROP MANAGEMENT AREA
(by Authority of Title 22, Chapter 10, Idaho Code)

000. -- 009. (RESERVED).

010. MANAGEMENT AREA.

01. Impact Area. Legal description of impact area of all included sections starting at the northern most side: Range 25 East, Township 13 South, Sections 14, 15, 16, East 1/2 20, 21, 22, 23, 24, 28, 29, 30, 31, 32, and 33; Range 25 East, Township 14 South, Sections 4, 5, 6, 7, 8, 9, 16, 17, 18, 19, 20, 21, 28, 29, and 30. This is the southern most side. R24 East, Township 13 South, Sections 25, 26, 27, SE 1/4 of 28, NE 1/4 of 33, 34, 35, 36, Range 24 East, Township 14 South, North 2 of 3, 2, 1, Range 26 East, Township 138, South 2 of 14, South 2 of 15, at intersect of 15 with Highway 77, follow west to intersect of Gamble Lane, then to SW corner of S 16, all of Sections 19, 20, 21, 22, 25, 26, 27, 28, 29, and 30. (7-7-92)

02. Boundary Line. Boundary line around area from the northern most point: NE corner of Section 14 of R26E, T13S to the NW corners 16, then south to SW corner of S16; then west 1/2 of S20, then south to line of S29, then west to the NW corner S27, R24E, T13S; then south 1/2, then west 1/2 into center of S28, R24E, T13S; then south one mile to center of S32; then East 1/2 to section line of S34; then south one mile to T14S, R24E, 1/2 section line of S3, then east to SW corner of Section 1, Range 24E, T14S; then south to the SW corner of S30, T14S, R25E; then east to SE corner of S28, T14S, R25E; then north to SE corner of S28, T13S, R25E; then east to SE corner of S18, T13S, R25E; then south to SW corner of S30, T13S, R26E; then east to Old Highway 30 in S25, T13S, R26E; then north along Old Highway 30 to 1/2 line S13, T13S, R26E; then west along 1/2 section line to west side S15 at the juncture of Highway 77; then SW along Highway 77 to the SW corner of S16, R26E, T13S; then west to NW corner of S24, T13S, R25E; then north to point of beginning at NE corner of S14, R25E, T13S. 011. -- 049. (RESERVED).

050. REGULATED ARTICLES.

All plants and plant parts of the potato, *Solanum tuberosum*. (7-7-92)

051. -- 099. (RESERVED).

100. DISEASES AND PESTS OF CONCERN.

- 01. Leaf Roll. Net necrosis or leaf roll. (7-7-92)
- 02. Ring Rot. Ring rot, *Corynebacterium sepedonicum*. (7-7-92)
- 03. Columbia Root Knot Nematode. Columbia root knot nematode, *Meloidogyne chitwoodii*. (7-7-92)
- 04. Green Peach Aphid. Green peach aphid, *Myzus persicae*, a vector of the leaf roll virus. (7-7-92)
- 05. Northern Root Knot Nematode. Northern root knot nematode, *Meloidogyne hapla*. (7-7-92)
- 06. Corky Ring Spot. Corky ring spot, a disease caused by tobacco rattle virus. (7-7-92)
- 07. Powdery Scab. Powdery scab, *Spongospora subterranea* (Wallr.) Lagerh. f. sp. subterranea. (7-7-92)

101. -- 149. (RESERVED).

150. PLANTING OF POTATOES.

01 Permitted Planting. Only microtubers, plantlets, prenuclear and nuclear for seed production, shall be allowed in the management area, except for experimental lines only from Tetonia Research and Extension Center. (7-7-92)

02. Certification. All plantings of potatoes except those in home gardens shall be entered for certification with Idaho Crop Improvement Association. (7-7-92)

03. Home Garden Inspection. Potatoes planted in home gardens shall be subject to inspection by the Department. (7-7-92)

151. -- 199. (RESERVED).

200. PEACH AND APRICOT TREES.

All peach or apricot trees growing in the area shall be identified and mapped. No new plantings of peach or apricot trees shall be allowed in the management area. (7-7-92)

201. -- 249. (RESERVED).

250. BEDDING PLANTS.

01. Inspection. All bedding plants shall be subject to inspection by the Director for aphids. If aphids are found, the plants shall be treated by a method approved by the Director. Such methods may include destruction of the infested plants. (7-7-92)

02. Treatment of Property. The Director may order treatment of property on which there are bedding plants or cut floral arrangements where he determines such treatment is necessary to control aphids. (7-7-92)

03. Spraying Cemeteries. All cemeteries within the management area must be sprayed immediately after the Memorial Day holiday. Such spraying shall be done in compliance with all civil and criminal statutes and rules concerning cemeteries. (7-7-92)

251. -- 299. (RESERVED).

300. STORAGE OF INFESTED POTATOES.

01. Failed Inspection. Potatoes which have not passed the two (2) Idaho Crop Improvement Association's summer field inspections shall not be stored in the Elba Seed Potato Crop Management Area. (7-7-92)

02. Notification of Ring Rot or Nematode. When ring rot or nematode is first detected in a lot of potatoes when the lot is removed from storage, the owner of the lot shall notify the Department before any portion of the lot is removed and the Department must approve the method of disposition of the portion to be removed. (7-7-92)

301. -- 349. (RESERVED).

350. CULL AND VOLUNTEER POTATOES.

01. Plant Growth. All plant growth on cull potato piles shall be controlled. (7-7-92)

02. Volunteer Potatoes. It shall be the responsibility of each landowner or manager to destroy all volunteer potatoes growing on summer fallow, set-aside and non-cultivated areas of his property. In the event that the landowner or manager fails to destroy such plants, the Director may order them destroyed at the expense of the landowner. (7-7-92)

351. -- 399. (RESERVED).

400. TRANSPORTATION OF POTATOES.

01. Covered and Sealed Vehicles. Potatoes in transit through the management area shall be only in covered and sealed vehicles. Potatoes in transit through the management area shall not be unloaded in the management area. (7-7-92)

02. Violations. Introduction into the management area of any of the pests or diseases listed in Section 100 by a contaminated vehicle or any other means shall constitute a violation of this rule. (7-7-92)

401. -- 449. (RESERVED).

450. INSPECTION.

01. Field Inspection. Field inspections for nuclear and generation one (G1) seed potatoes shall follow the policies and procedures of the Idaho Crop Improvement Association. (7-7-92)

02. Use of Tobacco. Field inspectors shall not smoke or chew tobacco during field inspections or within fifty (50) feet of a seed potato field. (7-7-92)

03. Disinfecting After Smoking. After smoking, inspectors shall disinfect their hands with soap and water before entering any field of seed potatoes. (7-7-92)

04. Tobacco Products Waste. Cigarette butts, pipe ashes and chewing tobacco spittle shall be kept in a closed container and taken out of the Elba Seed Potato Crop Management Area. (7-7-92)

05. Tobacco and Shipping. Inspectors shall not smoke or chew tobacco during the shipping point inspections or within fifty (50) feet of a seed potato storage facility. (7-7-92)

451. -- 499. (RESERVED).

500. FEDERAL AND STATE SHIPPING POINT INSPECTOR.

01. Inspection by Grower of Inspector Vehicle. Grower will be responsible to check and approve inspectors' vehicles for sanitation requirement prior to entering the Elba Seed Potato Management Area. Grower will be responsible to transport inspectors to grower storage area if inspector vehicle entry is denied. (7-7-92)

02. Grower Responsibility to Provide Inspection Equipment. Grower will furnish inspection table and required lighting for inspection of samples. Grower will be responsible for the maintenance or replacement of inspection equipment assigned to seed potato management area. (7-7-92)

03. Grower Responsibility to Provide Inspector Clothing. Grower shall furnish to the inspector all clothing for sanitation purposes required by the seed potato management area or reimburse the Federal-State Inspection Service for costs or sanitation equipment. (7-7-92)

501. -- 549. (RESERVED).

550. EXEMPTIONS.

Potatoes for human and animal consumption, grown outside the Elba Seed Potato Crop Management Area, shall be treated with a sprout inhibitor before being offered for sale within the Elba Seed Potato Crop Management Area. (7-7-92)

551. -- 599. (RESERVED).

600. VIOLATIONS.

Any person who violates any provision of this rule or who interferes with the carrying out of the provisions of this rule shall be guilty of a civil offense, and may be liable for treble the damages sustained and all costs of the suit including a reasonable attorney's fee. In addition, a civil fine of not more than three-thousand dollars (\$3,000) may be

imposed per incident of violation, as provided in Idaho Code, Section 22-1006.
