09.06.04 - RULES GOVERNING MINIMUM PHYSICAL PERFORMANCE STANDARDS TEST DEPARTMENT OF LABOR

000. LEGAL AUTHORITY.

The director of the Department of Labor is authorized under Section 44-109, Idaho Code, to adopt rules concerning the minimum medical and health standards for paid firemen. (2-26-93)

001. TITLE AND SCOPE.

These rules shall be cited as IDAPA 09, Title 06, Chapter 04, Rules Governing Minimum Physical Performance Standards Test, Department of Labor. These rules become the criteria for employment of paid firemen. (2-26-93)

002. WRITTEN INTERPRETATIONS.

This agency has no written interpretations of this chapter. "Report of Physical Performance Standards Tests;" Event No. 1, "Stair Climb;" Event No. 2, "Hose Pull;" Event No. 3, "Joist Walk;" Event No. 4, "Forcible Entry;" Event No. 5, "Ladder Operation;" Event No. 6, "Hose Drag/Couple;" and Event No. 7, "Simulated Rescue;" may be obtained from the Department of Labor, 277 North 6th Street, Statehouse Mail, Boise, Idaho 83720-6000. This chapter does not allow administrative relief of the provisions outlined herein.

011. REQUIREMENTS.

- 01. Idaho Code, Section 72-1428. The physical performance standards test shall be administered as set forth under provisions of Idaho Code, Section 72-1428. (8-25-88)
- 02. Instructions. The physical performance standards test shall be administered to all applicants as outlined in the instructions following this section. (8-25-88)
 - 03. Events. The applicant must pass the test for each one of the following events: (8-25-88)
 - a. Stair climb; (8-25-88)
 - b. Hose pull; (8-25-88)
 - c. Joist walk; (8-25-88)
 - d. Forcible entry; (8-25-88)
 - e. Ladder operation; (8-25-88)
 - f. Hose drag/couple; (8-25-88)
 - g. Simulated rescue; (8-25-88)
 - 04. Completion of Report. A Report of Physical Performance Standards Test shall be completed.

05. Retention of Report. The Report of Physical Performance Standards Test shall be placed in permanent files by the employer and a copy shall be sent to the Department of Labor. (8-25-88)

012. MINIMUM STANDARDS TESTING PROCEDURE.

This is a minimum standards testing procedure and does not prohibit fire departments from further tests of skills needed for their specific areas. (8-25-88)
