001. TITLE AND SCOPE (Rule 1).

The title of this chapter is the Endowment Care Cemetery Act Rules of the Idaho Department of Finance; and may be cited as IDAPA 12.01.06, "Rules Pursant to the Idaho Endowment Care Cemetery Act". These rules implement statutory intent with respect to the regulation of endowment or pertetual care cemeteries in the state of Idaho.
