**30.01.02 - RULES OF THE IDAHO STATE LIBRARY GOVERNING PARTICIPATION  
IN STATE LIBRARY - ADMINISTERED GRANTS**

**000. LEGAL AUTHORITY.**

In accordance with Section 33-2501, 33-2502, and 33-2504 Idaho Code, the State Library Board shall promulgate rules for the conduct of the public business entrusted to its care. (7-1-96)

**001. TITLE AND SCOPE.**

These rules shall be cited as IDAPA 30.01.02, "Rules of the Idaho State Library Governing Participation in State Library-Administered Grants". These rules establish eligibility requirements for participation in State Library-administered grants for library development purposes. (7-1-96)

**002. WRITTEN INTERPRETATIONS.**

In accordance with Section 67-5201(16)(b)(iv), Idaho Code, this agency has written statements that pertain to the interpretation of the rules of this chapter, or to the documentation of compliance with the rules of this chapter. The document is available for public inspection and copying at cost in the main office of this agency. (7-1-96)

**003. ADMINISTRATIVE APPEALS.**

All contested cases shall be governed by the provisions of IDAPA 04.11.01, "Idaho Rules of Administrative Procedure of the Attorney General". (7-1-96)

**011. ELIGIBILITY REQUIREMENTS FOR LIBRARIES PARTICIPATING IN GRANT PROGRAMS.**

An Idaho public, academic, school, or special library must meet certain requirements to be eligible to apply for or participate in State Library-administered grants for development purposes. Such requirements are set forth in the Idaho State Library Governing Policies and Procedures, (available for public inspection and copying in the main office of the Idaho State Library. Adoption, amendment, and repeal of Idaho State Library Governing Policies and Procedures are subject to public review and comment). (7-1-96)
