IDAPA 12 - DEPARTMENT OF FINANCE

12.01.03 - RULES PURSUANT TO THE IDAHO COLLECTION AGENCY LAW

000. LEGAL AUTHORITY (Rule 0).

This chapter is promulgated pursuant to Sections 26-2234 and 26-2248, Idaho Code. (7-1-93)

001. TITLE AND SCOPE (Rule 1).

The title of this chapter is the Collection Agency Rules of the Idaho Department of Finance; and may be cited as IDAPA 12.01.03, "Rules Pursuant to the Idaho Collection Agency Law". These rules implement statutory intent with respect to the regulation and supervision of collection agencies and licensed collection agency employees in the state of Idaho. (7-1-93)

002. WRITTEN INTERPRETATIONS--AGENCY ACCESS--FILINGS (Rule 2).

004. PUBLIC RECORDS ACT COMPLIANCE (Rule 4).

All rules contained in this chapter are public records. (7-1-93)

005. EXAMINATION FEES (Rule 5).

Section 26-2234, Idaho Code. Each collection agency shall pay to the Director of the Department of Finance a fee of fifteen dollars (\$15) per examiner hour for each annual examination of the collection agency conducted by the Department of Finance pursuant to Section 26-2234, Idaho Code. (7-1-93)
