**39.02.73 - RULES GOVERNING ACCIDENT PREVENTION COURSE**

**000. LEGAL AUTHORITY.**

Under authority of Sections 49-201 and 41-2515, Idaho Code, the Idaho Transportation Board adopts the following rule for criteria for a motor vehicle accident prevention course. (8-31-89)

**001. TITLE AND SCOPE.**

This rule establishes minimum standards for approval of a motor vehicle accident prevention course for the instruction of motor vehicle operators who are sixty-five (65) years of age or older. (8-31-89)

**002.-- 099. (RESERVED).**

**100. CRITERIA.**

**01. Instructor Certification.** Instructors must be certified by either the National Safety Council, American Automobile Association's program (AAA), American Association of Retired Persons (AARP) or an equivalent program, as determined by the Idaho Transportation Department. (8-31-89)

**02. Contents Of Course.** The contents of the course must be as outlined by either the National Safety Council, AAA Program, AARP's instructor's manual or an equivalent instructor's manual, as determined by the Idaho Transportation Department. (8-31-89)

**03. Length Of Class.** The course must consist of a minimum of eight (8) class hours, including classroom instruction or field driving instruction. (8-31-89)

**04. Proof Of Insurance.** For field driving instruction, if any, the course sponsor must provide adequate proof of insurance. (8-31-89)

**05. Sponsor Location.** The course sponsor must identify location(s) of established place of business, and a telephone number of a contact person who can be reached during regular working hours 8 a.m. to 5 p.m. (8-31-89)

**06. Participant Certification.** Each participant shall be issued a certificate of completion by the instructor. (8-31-89)

**101.-- 199. (RESERVED).**

**200. RECERTIFICATION.**

The sponsors of any approved Accident Prevention Course must apply to the Department for recertification on an annual basis. (8-31-89)
