IDAPA 41 TITLE 04 Chapter 01

41.04.01 - PUBLIC HEALTH DISTRICT 4 - COSTS AND CHARGES

000. LEGAL AUTHORITY.

Title 39, Chapter 4 and Title 39, Chapter 36, Idaho Code, grants authority to Public Health District 4 (Central District) to adopt rules, regulations and standards to protect the environmental and the health of the Public Health District 4 (Central District). Under the authority granted by Idaho Code 39-414, Public Health District 4 (Central District) publishes the following schedule to be effective on October 8, 1985.

001. TITLE AND SCOPE.

- **O1.** Title. These rules shall be known as IDAPA 41.04.01, "Public Health District 4, Costs and Charges". (7-1-93)
- **O2.** Scope. The provisions of these rules establish costs and charges for various services provided by Public Health District 4 (Central District). (7-1-93)

002. WRITTEN INTERPRETATIONS.

In accordance with Section 67-5201 (16)(b)(iv), Idaho Code, this agency has written statements which pertain to the interpretation of the rules of this chapter and fee schedules for costs and charges for various services provided by Public Health District IV. The document is available for public inspection and copying at cost in the main office of this agency.

003. ADMINISTRATIVE APPEALS.

Administrative appeals will be in accordance with IDAPA 04.11.01, "Idaho Rules of Administrative Procedure of the Attorney General". (7-1-93)

005. INCLUSIVE GENDER.

For all sections and subsection of all administrative rules in Idaho, the terms and references used in the masculine include the feminine and vice versa, as appropriate. (7-1-93)

006. SEVERABILITY.

The sections and subsections of all administrative rules in Idaho are presumed severable unless specifically provided to the contrary. If any rule, or part thereof, or the application of such rule to any person or circumstance is declared invalid, that invalidity does not affect the validity of any remaining portion. (7-1-93)

010. WOMEN'S HEALTH AND INFORMATION SERVICES.

Charges and costs are based on federal sliding scale guidelines. Requested services from zero (\$0) to fifty-five (\$55) dollars. Supplies zero (\$0) to nine (\$9) dollars. (7-1-93)

011. NURSING.

Costs and charges: (7-1-93)

- **01. Injections**. Zero (\$0) to (\$5) dollars plus actual vaccine costs. (7-1-93)
- **O2.** Blood Screening. Four dollars (\$4) plus actual lab costs. (7-1-93)
- **03. In-Home Injections**. Ten dollars (\$10) plus actual drug cost. (7-1-93)

012. ALL OTHER SERVICES.

Other services required of Public Health District IV by the public, governmental agencies, businesses or professional

agencies would incur charges and costs on an hourly basis or on a contracted lump-sum amount as follows: (7-1-93)

- **01. Paraprofessional Services**. Hourly Paraprofessional not to exceed twenty-five dollars (\$25) per employee hour. (7-1-93)
 - **O2. Professional Services**. Professional not to exceed fifty dollars (\$50) per employee hour. (7-1-93)
- **03. Contract Services.** Contract lump sum on time estimated, supplies at cost, travel as estimated by need. (7-1-93)
