**02.04.09 - RULES GOVERNING METHODS  
OF MAKING SANITATION RATINGS OF MILK SHIPPERS**

**000. LEGAL AUTHORITY.**

This chapter is adopted under the legal authority of Title 37, Chapter 4, Idaho Code. (4-8-94)

**001. TITLE AND SCOPE.**

**01. Title.** The title of this chapter is “Rules Governing Methods of Making Sanitation Ratings of Milk Shippers”. (4-6-05)

**02. Scope.** This chapter has the following scope: These rules shall govern procedures for the evaluation of the sanitary quality of milk and milk products, dairies, processing facilities as outlined in the Pasteurized Milk Ordinance. The official citation of this chapter is IDAPA 02.04.09.000 et seq. For example, this section’s citation is IDAPA 02.04.09.001. (4-8-94)

**002. WRITTEN INTERPRETATIONS.**

**003. ADMINISTRATIVE APPEAL.**

Hearing and appeal rights are set forth in Title 67, Chapter 52, Idaho Code. There is no provision for administrative appeals before the Idaho State Department of Agriculture under this chapter. (4-6-05)
