#### IDAPA 16 TITLE 02 CHAPTER 25

# 16.02.25 - RULES GOVERNING FEES CHARGED BY THE STATE LABORATORY

#### 000. LEGAL AUTHORITY.

Pursuant to Section 56-1003, Idaho Code, the Department of Health and Welfare is responsible for the supervision and administration of laboratories and administration of standards of tests for environmental pollution, chemical analyses and communicable diseases. Authority to set fees and establish charges for laboratory services is vested in the Board of Health and Welfare, pursuant to Section 56-1007, Idaho Code. (7-1-82)

#### 001. TITLE AND SCOPE.

**01. Title**. These rules are to be cited in full as Idaho Department of Health and Welfare Rules, IDAPA 16.02.25, "Rules Governing Fees Charged by the State Laboratory". (7-1-82)

**02.** Scope. The intent of these rules is to standardize all charges levied by the State Laboratory for services it provides. (7-1-82)

**03.** Limitation. The State Laboratory annually revises its fees and the charges detailed below will be reviewed by the Board on an annual basis and amended, as appropriate, in accordance with Chapter 52, Title 67, Idaho Code. (7-1-82)

# 002. POLICY.

The primary purpose of the Bureau of Laboratories of the Idaho Department of Health and Welfare, generally termed as the State Laboratory, is to provide laboratory services that are designed to support the various programs carried out by the other bureaus and divisions of the Department and programs delegated to the district health departments. Since it is not economically feasible for all departments of state governments to develop their own laboratories, it is also appropriate for the Department laboratories to provide services to other state agencies. (12-31-91)

#### 003. DEFINITIONS.

For the purposes of the rules contained in IDAPA 16.02.25, the following terms are used, as herein defined: (7-1-82)

01. Atomic Absorption Spectrophotometry. Analysis of samples using a specific instrumental (7-1-82)

**02. Board**. Idaho State Board of Health and Welfare. (12-31-91)

**03.** Chemical Tests. Individual. Analysis of various samples for a variety of organic, inorganic, and radio-chemical constituents. (7-1-82)

04. Department. Idaho Department of Health and Welfare. (12-31-91)

**05. Director**. The Director of the Idaho Department of Health and Welfare or his designee. (12-31-91)

**06.** Complete Inorganic Chemical Testing for Drinking Water. Analysis of potable water samples for all of the chemical parameters listed in Idaho Department of Environmental Quality Rules, IDAPA 58, Title 01, Chapter 08, "Idaho Rules For Public Drinking Water Systems". (12-31-91)

**07.** Forensic Laboratory Tests. Tests performed on legal evidence submitted by coroners, prosecutors, and law enforcement agencies. (7-1-82)

**08.** Most Probable Number Test. Bacteriological analysis of water samples using the multiple tube fermentation procedure. (7-1-82)

**09. Newborn Screening Tests**. Tests required under Idaho Department of Health and Welfare Rules, IDAPA 16.02.12, "Rules Governing Procedures and Testing to Be Performed on Newborn Infants". (12-31-91)

10. Pesticide Analyses. Testing of a variety of different materials for presence of pesticides and other toxic organic materials. (7-1-82)

11. Purity Test. Bacteriological analysis of drinking water samples to determine compliance with Idaho Department of Environmental Quality Rules, IDAPA 58.01.08, "Idaho Rules For Public Drinking Water Systems". (12-31-91)

12. Water Chemistry Tests, Individual. Chemical analysis of water samples for a variety of chemical (7-1-82)

**13.** Water Pollution Tests. Bacteriological, biological and chemical testing to determine the degree or amount of pollution in waste water samples. (7-1-82)

Before any information about a patient, client, registrant, applicant, or recipient contained in Department records may be released to the person who is the subject of the record, to another Department unit, to another governmental agency, or to a private individual or organization, the unit of the Department with custody of the record must comply with Idaho Department of Health and Welfare Rules, IDAPA 16.05.01, "Use and Disclosure of Department Records". (12-31-91)

#### 998. INCLUSIVE GENDER.

For the purpose of these rules, words used in the masculine gender include the feminine or vice versa, where appropriate. (7-1-82)

# 999. SEVERABILITY.

Idaho Department of Health and Welfare Rules, IDAPA 16.02.25, are severable. If any rule, or part thereof, or the application of such rule to any person, or circumstance is declared invalid, that invalidity does not affect the validity of any remaining portion of this chapter. (7-1-82)
