000. LEGAL AUTHORITY.

This chapter is adopted under the legal authority of Title 37, Chapter 4, Idaho Code.

001. TITLE AND SCOPE.

- **01. Title**. The title of this chapter is "Procedures Governing the Cooperative State-Public Health Service/Food and Drug Administration Program for Certification of Interstate Milk Shippers". (4-6-05)
- **O2. Scope**. This chapter has the following scope. These rules shall govern procedures for developing uniform milk sanitation enforcement methods for certification of interstate and intrastate movement of Grade A milk supplies as outlined in the "Grade A Pasteurized Milk Ordinance".
