TITLE 01  
CHAPTER 50**

**18.01.50 - ADOPTION OF THE 2006 INTERNATIONAL FIRE CODE**

**000. LEGAL AUTHORITY.**

These rules are promulgated and adopted pursuant to the authority vested in the Director under Title 41, Chapter 2, Idaho Code. (7-1-99)

**001. TITLE AND SCOPE.**

**01. Title.** These rules shall be cited as IDAPA 18.01.50, Rules of the Idaho Department of Insurance, Title 01, Chapter 50, "Adoption of the 2006 International Fire Code." (4-2-08)

**02. Scope.** Pursuant to the authority provided by Section 41-253, Idaho Code, the Idaho Fire Marshal hereby adopts the 2006 edition of the International Fire Code as the minimum standard for the protection of life and property from fire and explosion for the state of Idaho. (4-2-08)

**002. WRITTEN INTERPRETATIONS.**

In accordance with Section 67-5201(19)(b)(iv), Idaho Code, this agency may have written statements which pertain to the interpretation of the rules of the chapter, or the documentation of compliance with the rules of this chapter. These documents will be available for public inspection and copying at cost in the main office and each regional or district office of this agency. (7-1-99)

**003. ADMINISTRATIVE APPEALS.**

Any administrative appeal regarding this chapter should be made in accordance with Chapter 2, Title 41, Idaho Code, and to the extent not in conflict therewith, Chapter 52, Title 67, Idaho Code, as well as IDAPA 04.11.01, "Idaho Rules of Administrative Procedure of the Attorney General." (5-3-03)

**004. INCORPORATION BY REFERENCE.**

**01. 2006 International Fire Code.** In accordance with Section 67-5229, Idaho Code, and pursuant to the authority provided by Section 41-253, Idaho Code, the Idaho State Fire Marshal hereby adopts the 2006 edition of the International Fire Code as published by the International Code Council with the following revisions, additions, deletions and appendixes. (4-2-08)

**02. Availability of Referenced Material.** Copies of the 2006 edition of the International Fire Code are available for public inspection at the office of the State Fire Marshal, the State Law Library, and the State Legislative Council. Copies of the 2006 International Fire Code may be procured by writing the International Code Council, Northwest Resource Center, 2122 112th Ave NE, Suite C, Bellevue, WA 98004. (4-2-08)

**005. -- 009. (RESERVED).**

**010. CONSTRUCTION AND DESIGN PROVISIONS, SECTION 102.1, INTERNATIONAL FIRE CODE.**

Delete Item No. 3 of Section 102.1, International Fire Code. (5-3-03)

**011. GENERAL AUTHORITY AND RESPONSIBILITIES, SECTION 104.1, INTERNATIONAL FIRE CODE.**

Add the following second paragraph to Section 104.1, General, International Fire Code: (5-3-03)

**01. Fire Chief's Authority.** The fire chief is authorized to administer and enforce this code. Under the chief's direction, the fire department is authorized to enforce all ordinances of the jurisdiction pertaining to: (5-3-03)

**a.** The prevention of fires; (5-3-03)

**b.** The suppression or extinguishment of dangerous or hazardous fires; (5-3-03)

- c. The storage, use and handling of hazardous materials; (5-3-03)
- d. The installation and maintenance of automatic, manual and other private fire alarm systems and fire-extinguishing equipment; (5-3-03)
- e. The maintenance and regulation of fire escapes; (5-3-03)
- f. The maintenance of fire protection and the elimination of fire hazards on land and in buildings, and other property, including those under construction; (5-3-03)
- g. The maintenance of means of egress; and (5-3-03)
- h. The investigation of the cause, origin and circumstances of fire and unauthorized releases of hazardous materials, for authority related to control and investigation of emergency scenes, see Section 104.11. (5-3-03)

**012. -- 015. (RESERVED).**

**016. PERMIT REQUIRED, SECTION 105.1.1, INTERNATIONAL FIRE CODE.**

A permit, if required by the local jurisdiction, shall be obtained from the designated official prior to engaging in activities requiring a permit within the local jurisdiction. (4-2-08)

**017. VIOLATION PENALTIES, SECTION 109.3, INTERNATIONAL FIRE CODE.**

In Section 109.3, Violation Penalties, International Fire Code, delete the sentence that includes “shall be guilty of a,” and replace with the word “misdemeanor.” (4-2-08)

**018. FAILURE TO COMPLY, SECTION 111.4, INTERNATIONAL FIRE CODE.**

In Section 111.4, International Fire Code, delete this entire section. (5-3-03)

**019. (RESERVED).**

**020. DEFINITION OF CODE OFFICIAL, SECTION 202, INTERNATIONAL FIRE CODE.**

Add “or as appropriate the Idaho State Fire Marshal” to the end of the definition for code official. (5-3-03)

**021. -- 025. (RESERVED).**

**026. SECTION 903.2.7 GROUP R AUTOMATIC SPRINKLER SYSTEM REQUIREMENTS.**

Add to the paragraph, “Exception: automatic sprinkler systems are not required in 3- or 4-unit Group R buildings.” (4-6-05)

**027. SECTION 906.1, PORTABLE FIRE EXTINGUISHERS, WHERE REQUIRED.**

Item 1 Exception: delete the exception. (4-6-05)

**028. – 036. (RESERVED).**

**037. FIRE ALARM AND DETECTION SYSTEMS, SECTION 907.1, INTERNATIONAL FIRE CODE.**

**01. Notification Devices.** When fire alarm systems not required by the International Fire Code are installed, the notification devices shall meet the minimum design and installation requirements for systems which are required by this code. Intent: (Non-required fire alarm systems shall provide the same level of occupant notification that required systems provide). (5-3-03)

**02. Partial or Limited Detection Systems Are Allowed.** If notification devices are provided, they must meet Subsection 037.01 above. (7-1-99)

**038. -- 040. (RESERVED).**

**041. EXPLOSIVES AND FIREWORKS, CHAPTER 33, INTERNATIONAL FIRE CODE.**

Delete Sections 3301.1.3, 3301.2.2, 3301.2.3, 3301.2.4.2, and 3308.1 through 3308.3. (5-3-03)

**042. -- 045. (RESERVED).**

**046. UNDERGROUND TANKS OUT OF SERVICE FOR ONE YEAR, SECTION 3404.2.13.1.3 INTERNATIONAL FIRE CODE.**

Add to Section 3404.2.13.1.3, International Fire Code, the following paragraph: Upon approval of the Chief underground tanks that comply with the performance standards for new or upgraded underground tanks set forth in Title 40 Section 280.20 or 280.21 of the Code of Federal Regulations may remain out of service indefinitely so long as they remain in compliance with the operation, maintenance and release detection requirements of the federal rule. (5-3-03)

**047. -- 051. (RESERVED).**
