This chapter is adopted under the legal authority of Section 22-110, Idaho Code.

001. TITLE AND SCOPE. 01. Title. The title of this chapter is "Rules Governing the Stockpiling of Agricultural Waste." (3-29-10)Scope. These Rules govern the Stockpiling of Agricultural Waste at Agricultural Operations to safeguard and protect animals, man, and the environment.
