#### 34.02.01 - PRESIDENTIAL PRIMARY

#### 000. -- 010. (RESERVED)

#### 011. FORMS.

- **01. Forms for Nominating Petition**. Pursuant to the authority of Section 34-740, Idaho Code, the official form for the petition for nomination as required by Section 34-732, Idaho Code, is hereby adopted. This form shall be designated as "PP-1." (7-1-93)
- **02. Form for Delegate List**. Pursuant to the authority of Section 34-740, Idaho Code, the official form for the candidate's delegate list as required by Section 34-735, Idaho Code, is hereby adopted. This form shall be designated as "PP-2." (7-1-93)
- **03. Form for Signature Check List**. Pursuant to the authority of Section 34-740, Idaho Code, the official form for the signature check list as required by Section 34-732, Idaho Code, is hereby adopted. This form shall be designated as "PP-3." (7-1-93)

#### 012. BALLOT PLACEMENT.

- **01.** Candidate Must Be from Qualified Party. No candidate shall be placed on the Presidential Preference Primary ballot either by the Secretary of State or by petition unless such candidate is a member of a party qualified, according to the provisions of Section 34-501, Idaho Code, to be placed on the ballot in Idaho. (7-1-93)
- **02. Nomination by Petition Prohibition**. No petition for nomination shall be allowed for candidates who have already been placed on the ballot by the Secretary of State. (7-1-93)

#### 013. WRITE-INS.

- **01. Write-Ins Are Allowed.** Write-in votes shall be allowed in the Presidential Preference Primary. In order for a write-in candidate to receive any delegate votes for his party he must receive more than five percent (5%) of the total vote cast for his particular party. (7-1-93)
- **O2. Delegate List for Write-In Candidate.** If a write-in candidate receives more than five percent (5%) of the total votes cast for his party, he shall submit a list of proposed delegates no later than ten (10) days following the official canvass of the Presidential Preference Primary. Said list shall comply with the provisions of Section 34-735, Idaho Code, except as to time of filing. (7-1-93)
