**02.04.06 - RULES GOVERNING LICENSED DAIRY PLANTS**

**000. LEGAL AUTHORITY.**

This chapter is adopted under the legal authority of Title 37, Chapter 5, Idaho Code. (4-11-15)

**001. TITLE AND SCOPE.**

**01. Title.** The title of this chapter is rules of the Department of Agriculture governing IDAPA 02.04.06, "Rules Governing Licensed Dairy Plants." (4-11-15)

**02. Scope.** This chapter has the following scope: These rules shall govern the requirements for the design, construction, and operation of dairy plants licensed to process milk for manufacturing purposes. The official citation of this chapter is IDAPA 02.04.06.000 et seq. For example, this section's citation is IDAPA 02.04.06.001. (4-6-05)

**002. WRITTEN INTERPRETATIONS.**

There are no written interpretations of these rules. (4-6-05)

**003. ADMINISTRATIVE APPEAL.**

Hearing and appeal rights are set forth in Title 67, Chapter 52, Idaho Code. There is no provision for administrative appeals before the Department of Agriculture under this chapter. (4-6-05)
