### **IDAPA 02 – DEPARTMENT OF AGRICULTURE**

#### 02.01.02 - INTEREST CHARGE RULES

#### 000. LEGAL AUTHORITY.

This chapter is adopted under the legal authority of Idaho Code Section 22-103(22).(6-30-19)T001. TITLE AND SCOPE.

**01. Title**. The title of this chapter is IDAPA 02.01.02, "Interest Charge Rules." (6-30-19)T

**02. Scope**. These rules govern the interest charged on past due accounts, establish the interest rate, and provide for extreme financial hardship waiver. (6-30-19)T

**01.** Interest Charge on Late Accounts. An interest charge may be assessed on all accounts which are thirty (30) days past due from the initial billing date or the assessment due date. In cases of extreme financial hardship experienced by the debtor, the assessment may be waived. (4-22-91)

**02.** Interest Rate. Twelve percent (12%) per annum.
