#### 39.03.62 - RULES GOVERNING LOGO SIGNS

#### 000. LEGAL AUTHORITY.

The Idaho Transportation Board adopts this rule under the authority of Sections 40-312, 40-313, 40-1911(5) and 67-5229, Idaho Code, and U.S.C. Title 23, Chapter 1, 131 and 156. (3-19-07)

### 001. TITLE AND SCOPE.

- **01. Title.** These rules are titled IDAPA 39.03.62, "Rules Governing Logo Signs." (3-19-07)
- **O2.** Scope. These rules provide regulations for the installation and administration of specific service signs informing motorists of gas, food, lodging, camping, attractions, and 24-hour pharmacies with their related tourist services, which are available at facilities accessible to and from eligible interchanges. (3-19-07)
