## 02.04.04 – RULES FOR ARTIFICIAL DAIRY PRODUCTS

### 000. LEGAL AUTHORITY.

This chapter is adopted under the legal authority of Section 37-303, Idaho Code.

### 001. TITLE AND SCOPE.

**01. Title.** The title of this chapter is IDAPA 02.04.04, “Rules for Artificial Dairy Products.” (3-20-20)

**02. Scope.** These rules govern the process, sale, and distribution of artificial dairy products. (3-20-20)

### 002. – 011. (RESERVED)

### 100. GENERAL.

The Director of the Idaho Department of Agriculture or the Director’s authorized representative will issue and enforce a written stop sale order to the owner or custodian of any quantity of artificial dairy products that has been determined by the Department of Agriculture to be in violation of Sections 37-315 through 37-318, Idaho Code. The order shall prohibit further sale, processing, or movement of such artificial dairy products, until the Department has evidence that the law has been complied with. (3-20-20)
