#### 12.01.11 – Rules Pursuant to the Idaho Collection Agency Act

#### Who does this rule apply to?

The rule applies to persons engaging in debt collection, credit counseling or debt management, debt settlement, and credit repair in Idaho.

The rule provides a definition of the federal Fair Debt Collection Practices Act, incorporated by reference within the Idaho Collection Agency Act.

#### What is the legal authority for the agency to promulgate this rule?
